

MEMORANDUM OF UNDERSTANDING

To provide subsidies and assistance to Lecturerships of Spanish from the Ministry of Foreign Affairs and Cooperation (MAEC)- Spanish Agency For International Cooperation and Development (AECID)

Between

AECID and the University of Rajasthan

The Director of Cultural and Scientific Relations, on behalf and in representation of the Spanish Agency for International Cooperation and Development (AECID), a national Agency attached to the Ministry of Foreign Affairs and Cooperation of Spain.

The President of the University of Rajasthan on behalf and in representation of the said University.

With the aim of supporting Spanish studies -language, culture and literature- in the University, contributing to their academic and institutional development and consolidation, agree on the following terms to include in the AECID annual notice of its Program of Support of Spanish Lecturers in Foreign Universities a vacancy for such a post in the mentioned University.

- 1.- The Direction for Cultural and Scientific Relations -DRCC- of the AECID, through the Embassy of Spain, will propose a candidate (a shortlist of suitable candidates, between three and five) for the post of Lecturer at the Department of European Language, Literature and Culture Studies. This candidate will have been selected amongst all the applicants for the post.
- 2.- The Lecturer will have to be approved by the University in writing to DRCC. The candidate will have to fit the profile and duties defined by the University.
- 3.- The Lecturer will also assume cultural duties in cooperation with the Embassy to be developed within the University, compatible with his academic duties.
- 4.- The Lecturer will be entitled to apply to DRCC and the University for renewal of his post, on an annual basis, for a maximum of three academic years.
- 5 -The University will finalize a contract with the Lecturer/Tutor on taking up his / her academic post. The contract will include – provided that in case a well furnished and properly maintained free accommodation, (or the tutor may hire a flat or a house of she / he so desires, for which the University is not bound to pay the HRA and not responsible for her / his safety an security). Local monthly salary, facilitated for further training.

6.- DRCC will grant the Lecturer a monthly subsidy and medical insurance according to the terms of the annual notice published in the Spanish government's official gazette (Boletín Oficial del Estado).

7.- The University will assist the Lecturer with all the official formalities –visa, residence permit, etc.- so that he may take up his post as soon as possible.

8.- DRCC through the Embassy, will add bibliographic material in Spanish - according to its budgetary resources- to the collection of such material in the Spanish Department.


9.- The University may recognize the Diploma on Spanish as a Foreign Language (DELE) and will facilitate the carrying out of the exams to obtain the aforementioned Diploma in the conditions agreed with the Instituto Cervantes.

10.- This MOU in view of its objectives –to contribute to the institutional and academic development and consolidation of Spanish studies in the University of Rajasthan, and to facilitate eventually their self-sustainability-, will be valid for an initial minimum cycle of 3 years to a maximum of 3 cycles -9 academic years-, regardless of the possibility that AECID, through the Embassy, or the University, may indicate in writing the cancellation of the MOU after giving three months' prior notice.

11.- At the end of the initial cycle mentioned, AECID and the University, will jointly evaluate the attainment of the objectives envisaged in the preamble and clauses of this Memorandum, allowing them to reconsider their agreement by mutual consent.
