





#### **About the Seminar**

Accounting knowledge is essential for the sustainable development of the country and enhancing decision making process of the business entities. The success of any industrial or commercial concern is very much dependent upon perfect knowledge of accounting related rules, regulation, accounting standards and other related fields.

In Companies Act, 2013 certain significant amendments regarding financial statements, audit and reporting practices have been introduced. In comparison with the requirements of the companies Act., 1956 several additional requirements such as preparation of consolidated financial statements, additional reporting requirements for the directors, rotation of audit firm, Corporate Social Responsibility has been introduced. With a view to enhance audit effectiveness and accountability of the auditors, certain extensive changes within the area of audit and auditors have been introduced in the Companies Act., 2013.

The Companies Act., 2013 also mandates that the companies would be required to spend a certain percent of the average net profits of the immediately preceding three years on CSR activities.

The basic object of the seminar is to discuss the effect of above changes in the companies law in managing the corporate sector efficiently and to safeguard the interest of all stakeholders.
